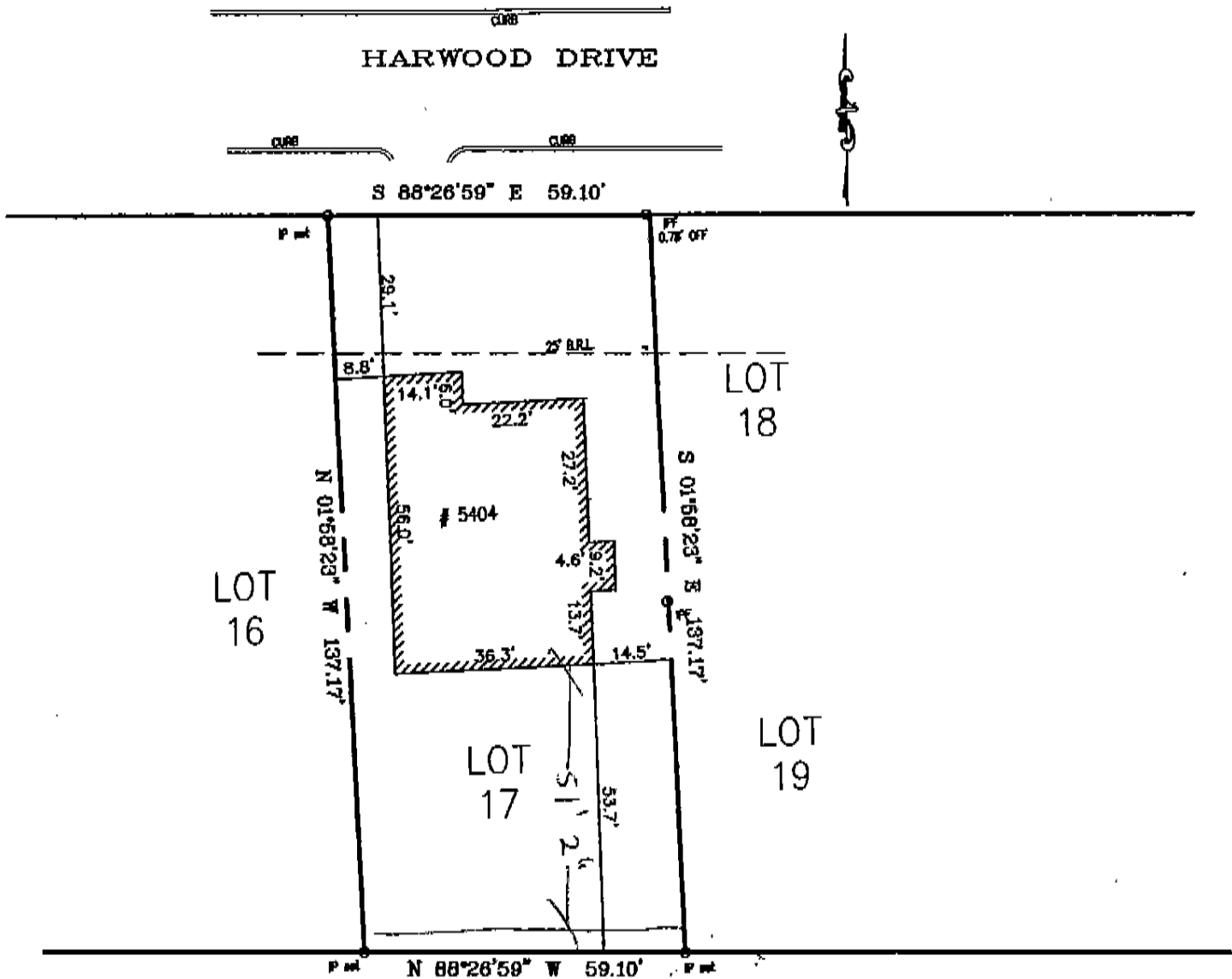

 purpose whatever;

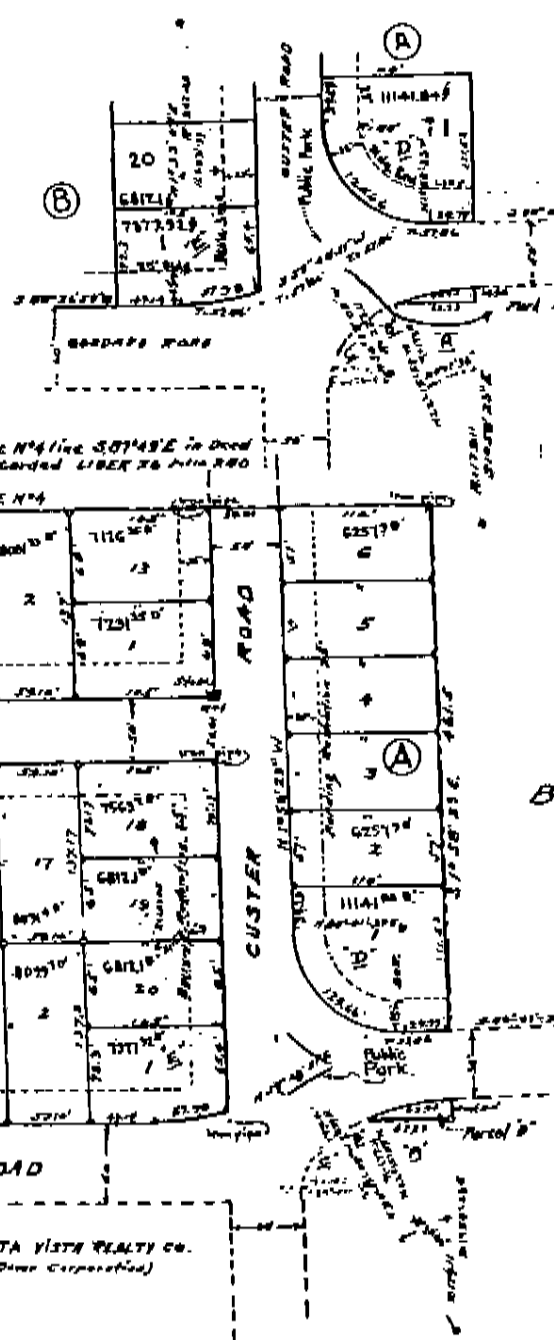
